SUMMARY ANNUAL REPORT FOR NORTHERN ILLINOIS ANNUITY FUND

This is a summary of the annual report for the Northern Illinois Annuity Fund (Employer Identification Number 36-3449836, Plan Number 001) for the Plan year 06/01/2019 through 05/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the Plan are provided by insurance contracts and a trust fund. Plan expenses were \$9,854,240. These expenses included \$848,602 in administrative expenses and \$9,005,638 in benefits paid to participants and beneficiaries, \$0 in certain deemed and/or corrective distributions, and \$0 in other expenses. A total of 6427 persons were participants in or beneficiaries of the Plan at the end of the Plan year.

The value of Plan assets, after subtracting liabilities of the Plan, was \$112,754,315 as of the end of the Plan year, compared to \$104,131,334 as of the beginning of the Plan year. During the Plan year, the Plan experienced a change in its net assets of \$8,622,981. This change includes unrealized appreciation or depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$18,477,221, including employer contributions of \$12,549,327, employee contributions of \$0, other contributions/other income of \$0, and earnings from investments of \$5,927,894.

The Plan has a contract which allocates funds toward Annuity Contracts.
